



## **TRAVEL AND ENTRY REQUIREMENTS FOR DECEMBER 2021 + JANUARY 2022 VOYAGES**

The information presented below is current as of December 21, 2021. As health and entry requirements vary by country and are rapidly evolving, we strongly suggest you re-check this information five (5) days prior to commencing travel.

### **BEFORE YOU TRAVEL**

Please ensure that prior to commencing travel, you have all of the travel documents and pre-travel testing that are required:

- Air tickets and cruise documents
- Passport
- Original/Official COVID-19 vaccination record – hard copy and/or electronic
- Pre-travel antigen or PCR test results
- Your completed PLF, if required

### **PRE-EMBARKATION TESTING**

**Until further notice, all guests will undergo complimentary pier-side COVID-19 antigen testing prior to embarkation.** Additionally, we strongly recommend that all guests consult with local government websites to determine the country-specific information for your port of embarkation as many countries require a negative COVID-19 PCR test that is not older than 48 or 72 hours prior to arrival in-country.

**Even if the country where your cruise embarks does not require a negative COVID-19 PCR test for entry, Oceania Cruises strongly recommends you obtain a PCR test not more than 72 hours prior to embarkation. If a PCR test is not readily available, then we encourage guests to, at a minimum, take a laboratory-administered COVID-19 antigen test not more than 72 hours prior to embarkation.**

Guests that fail to test prior to departure, or cannot provide proof of a negative laboratory-supplied test result, and subsequently test positive for COVID-19 upon embarkation will not be reimbursed for quarantine or return arrangements.

### **FACE MASK REQUIREMENTS**

The health and safety of our guests and crew is always our number one priority and at the advice of the medical experts on our **SailSAFE Global Health and Wellness Council**, for all sailings departing after December 18, 2021 and until further notice, all guests will be required to wear face masks in all public areas of the ship, unless eating or drinking while seated. Masks are also required outdoors when physical distancing of at least six (6) feet cannot be maintained. Face masks must fully cover the nose and mouth, down to the chin. Gaiters and other loose facial coverings are not acceptable. Additionally, many destinations have very specific face mask requirements for going ashore. We strongly recommend all guests travel with an adequate supply of medical-grade masks, commonly known as surgical masks or KN-95 masks. Should you require additional masks while traveling, all ships will be adequately stocked and you may obtain them from your Stateroom or Suite Attendant or at Reception. We thank you for your cooperation and understanding. Please note: this guidance is subject to change as the global health map evolves.

### **TRAVEL/MEDICAL INSURANCE**

Oceania Cruises strongly urges all guests to travel with adequate travel insurance to cover unforeseen medical expenses. Some destinations have enacted mandates for all travelers to carry travel-medical insurance. South American destinations have very specific insurance requirements for covid-19 cover and Oceania Cruises will satisfy the requirements for all guests on those voyages, free of charge.

### **CHECK-IN AND CRUISE TERMINAL ARRIVAL**

All guests are reminded to arrive at the cruise terminal within a 30-minute window of their reserved embarkation time.

### **EXPLORING ASHORE**

At the time of issue of this guidance, many destinations are updating their guidelines on independent touring. While the majority of destinations on our itineraries permit guests to tour independently, the situation remains fluid and may change without notice. The latest country-specific information is listed below and is subject to change.

### **REQUIRED TESTING DURING YOUR VOYAGE**

Any testing that may be required by authorities to enter a port of call will be carried out aboard the vessel and will be complimentary. Additionally, Oceania Cruises will conduct complimentary antigen testing for all guests on the final day of the voyage. PCR testing will be available for those destinations that require it. This testing can be used to satisfy any requirements for onward travel after your voyage.

### **VACCINATION REQUIREMENTS**

All guests and crew are required to be fully vaccinated. Fully vaccinated means that you have fulfilled your complete cycle of inoculations (a single shot of a single dose vaccine or two shots of a dual dose vaccine) and are 15 days or more past your final shot.

**Oceania Cruises strongly recommends that all guests receive a COVID-19 “booster” prior to travel.**

**Approved Vaccinations**

- Any FDA/EMA/WHO authorized single brand vaccination protocol  $\geq 2$  weeks after receipt of the final dose.
  - I.e., J&J Janssen, Pfizer-BioNTech, Moderna, AstraZeneca/Oxford (Vaxzevria & CoviShield), etc.
  - A mixed vaccination combination of two doses of an FDA approved/authorized or WHO Emergency Use Listed (EUL) COVID-19 two-dose series with a minimum interval of 17 days.
- **Note:** Individuals receiving a Janssen COVID-19 vaccine before or after another COVID-19 vaccine are considered fully vaccinated against COVID-19  $\geq 2$  weeks after receipt of the single dose of the Janssen vaccine.
- **Current Unauthorized Vaccine:** Sputnik V, Inactivated SARS-CoV-2 Vaccine (Vero-Cell), Novavax, Covovax.
- **Children between the ages of 5-11:** Allowed provided they have received and completed the full vaccination protocol  $\geq 2$  weeks after receipt of the final dose of Pfizer-BioNTech only.

**Notes:** Individuals receiving a J&J Janssen COVID-19 vaccine before or after another COVID-19 vaccine are considered fully vaccinated against COVID-19  $\geq 2$  weeks after receipt of the single dose of the J&J Janssen vaccine.

Vaccinations received via clinical trials will not be accepted as they do not specify vaccine received. A single shot of a dual dose vaccine or antibodies from COVID-19 recovery is NOT considered being fully vaccinated. Therefore, two administered doses/shots of AstraZeneca, Pfizer-BioNTech, Moderna, Sinopharm or Sinovac or a single shot of a single dose vaccination  $\geq 15$  days equals fully vaccinated.

**MARINA VOYAGE REQUIREMENTS – JANUARY 8, 2022**

**ARGENTINA**

All guests must be in possession of a valid, negative, PCR covid-19 test result to board your flight to Argentina. Your test results may not be more than 72 hours old at the time of arrival in Argentina. If your test results are older than 72 hours, you may be required to undergo PCR testing at the airport prior to being released or you may be denied entry.

Additionally, Argentina also requires a negative PCR test result for all travelers embarking cruise ships. If you are arriving to Argentina on embarkation day, you may utilize the same PCR test that was used to enter Argentina as long as it will not be more than 72 hours old at the time of embarkation.

### Summary of Requirements

- For guests that are boarding the ship immediately upon arrival in Argentina:
  - At the time of check-in, guests will be required to provide proof of a negative COVID-19 PCR test result administered by a verified third party within **72 hours of embarkation.**
  - As you are embarking the ship on Saturday afternoon, the test must be taken no earlier than Wednesday the 5<sup>th</sup> in the afternoon or evening. See the chart below with suggested timeframe for testing.
  - Complete and show the sworn affidavit for arrival to and departure from all ports in Argentina. The form can be found here:

- For guests that live in Argentina or who are staying in Argentina in a hotel prior to boarding our ship:
  - At the time of check-in, guests will be required to provide proof of a negative COVID-19 PCR test results administered by a verified third party within **48 hours of embarkation.**
  - As you are embarking the ship on Saturday the 8<sup>th</sup>, the test must be taken no earlier than 4 pm local time in Buenos Aires on Thursday the 6<sup>th</sup>.
  - Complete and show the sworn affidavit for arrival to and departure from all ports in Argentina. The form can be found here:

If you are embarking the ship on the same day you enter Argentina, we offer the following timeline guidance for testing.

For arrival into Argentina on January 8, 2022 and to utilize the same PCR test for embarkation, you should not test earlier than the date and time listed below.

#### **If Traveling from the Americas:**

11 am Pacific, January 5, 2022  
12 pm Mountain, January 5, 2022  
1 pm Central, January 5, 2022  
2 pm Eastern, January 5, 2022  
3 pm Atlantic, January 5, 2022

#### **If Traveling from the United Kingdom or Europe:**

7 pm Western European, January 5, 2022  
8 pm Central European, January 5, 2022

In some instances, guests may wish to secure their PCR test to begin travel to Argentina and secure a second PCR test from an airport location to present at embarkation.

For guests traveling from the U.K. or Europe, PCR testing is also available in virtually every major gateway.

Please allow ample additional time in-airport to accomplish the testing.

#### **Embarkation Testing in Buenos Aires**

Once you have presented your valid, negative PCR test you will undergo complimentary antigen testing prior to boarding. You will receive a registration link for the antigen testing approximately five (5) days prior to embarkation.

#### **URUGUAY**

**Testing Required:** All guests must present a negative COVID-19 PCR test result, not more than 72 hours old. This testing will be formed by the Medical Team onboard Marina, at no cost.

**Entry Restrictions:** All guests must present proof of COVID-19 vaccination, and proof of health insurance, with COVID-19 coverage, that was issued in the country of your origin. Additionally, all guests must complete an electronic declaration form which can be found on the link below. We encourage guests to complete this declaration prior to commencing travel.

## **CHILE**

**Testing Required:** Upon arrival in Chile, all guests must present a negative COVID-19 test result that is not more than 72 hours old. Testing for all ports in Chile will be performed onboard by the ship's medical team, free of charge.

**Entry Restrictions: The Chilean government requires all travelers entering Chile to verify their identity and certify their vaccination status. Travelers must complete this process not more than 45 days prior to entering Chile and not less than 30 days prior to entering Chile as the approval process can take up to 30 days for the Chilean government to complete and issue an approval.**

To complete the required "Mobility Pass" for entry into Chile, you will need to have both your passport and COVID-19 vaccination information readily at hand. You will also need a photo (jpeg) or PDF of your passport and vaccination card ready to upload.

NOTE: Oceania Cruises strongly suggests that you complete the "Mobility Pass" application on a desktop or laptop computer and use either Microsoft Edge or Google Chrome. By doing so, the majority of the application website should automatically translate to English. The user experience on mobile devices and/or Apple devices may not provide for as smooth or easy an experience for the applicant. Please remember to have both your passport and COVID-19 vaccination information readily at hand. You will also need a photo (jpeg) or PDF of your passport and vaccination card ready to upload.

We strongly recommend that you complete this application not later than 30 days prior to your planned arrival in Chile. Please retain a copy of your confirmation email once you have completed the application. Guests who are not in possession of a "Mobility Pass" approval from the Chilean government may not enter Chile and may be denied embarkation.

## **MARINA VOYAGE REQUIREMENTS – JANUARY 28, 2022**

### **INSURANCE REQUIREMENTS**

As Chile, Argentina, and Uruguay have established very specific insurance regulations for entering travelers that have caused concern for many of you, we are pleased to inform you that Oceania Cruises has acquired the necessary coverage for all guests, of all nationalities.

**This coverage will be provided to you, free of charge, compliments of Oceania Cruises, to ensure your peace of mind.**

This coverage will meet or surpass all currently established insurance requirements for Chile, Argentina, and Uruguay. If you hold a current travel insurance policy, this policy will provide you with coverage above and beyond what you currently hold.

The policy is via AON-Affinity and includes up to \$50,000 USD coverage for Emergency Accident Medical Expenses and for Emergency Sickness Medical Expenses and most importantly, covers Covid-19 related treatment if required.

**There is No Action Required on your part,** Oceania Cruises will acquire the coverage for you, free of charge, as noted above. You will then receive an email notification from our Special Services department that contains your enrollment confirmation, which provides a link to certificate of coverage and the policy information.

## **CHILE**

**Testing Required:** Upon arrival in Chile, all guests must present a negative COVID-19 test result that is not more than 72 hours old. Additionally, all guests are required to undergo an additional COVID-19 test upon arrival. Travelers arriving in-country prior to December 19 may be asked to quarantine at their hotel until a negative test result is received.

**Entry Restrictions:** The Chilean government requires all travelers entering Chile to verify their identity and certify their vaccination status. Travelers must complete this process not more than 45 days prior to entering Chile and not less than 30 days prior to entering Chile as the approval process can take up to 30 days for the Chilean government to complete and issue an approval.

To complete the required "Mobility Pass" for entry into Chile, you will need to have both your passport and COVID-19 vaccination information readily at hand. You will also need a photo (jpeg) or PDF of your passport and vaccination card ready to upload.

NOTE: Oceania Cruises strongly suggests that you complete the "Mobility Pass" application on a desktop or laptop computer and use either Microsoft Edge or Google Chrome. By doing so, the majority of the application website should automatically translate to English. The user experience on mobile devices and/or Apple devices may not provide for as smooth or easy an experience for the applicant.

We strongly recommend that you complete this application not later than 30 days prior to your planned arrival in Chile. The Chilean government cannot guarantee that applications received within 30 days of arrival can be processed and approved by the time of your arrival in Chile.

## URUGUAY

**Testing Required:** All guests must present a negative COVID-19 PCR test result, not more than 72 hours old. This testing will be formed by the ship's Medical Team at no cost.

**Entry Restrictions:** All guests must present proof of COVID-19 vaccination, and proof of health insurance, with COVID-19 coverage, that was issued in the country of your origin. Additionally, all guests must complete an electronic declaration form which can be found on the link below. We encourage guests to complete this declaration prior to commencing travel.

## ARGENTINA

**Testing Required:** All guests must present a negative COVID-19 test result not more than 72 hours old. Oceania Cruises will provide complimentary testing on board which will be performed by the ship's Medical Team at no cost.

**Entry Restrictions:** All guests must complete an electronic health declaration form 48 hours before arrival. Guests will need to complete this form while on board *Marina*; it can be found [here](#).

## RIVIERA VOYAGE ENTRY REQUIREMENTS – DECEMBER 23, 2021

### ARUBA

**Testing Required:** No

**Entry Restrictions:** None

### BONAIRE

**Testing Required:** All guests must present a negative COVID-19 antigen test result that is not more than 72 hours old, upon arrival. Complimentary testing will be performed by *Riviera's* Medical Team.

**Entry Restrictions:** Guests may be requested to provide proof of vaccination to proceed ashore.

### CURACAO

**Testing Required:** No

**Entry Restrictions:** None

### GRENADA

**Testing Required:** All guests must present a negative COVID-19 antigen test result that is not more than 72 hours old, upon arrival. Complimentary testing will be performed by *Riviera's* Medical Team.

**Entry Restrictions:** Guests must provide proof of vaccination to proceed ashore.

All guests must apply for a "Pure Safe" travel authorization prior to travel. The authorization form should be completed prior to commencing travel and can be found here: [Pure Safe Travel Authorization Application](#).

**Vaccination Note:** At this time, the authorities in Grenada only recognize travelers as fully vaccinated if they have been inoculated with Oxford/AstraZeneca, Serum Institute of India Covidshield (Oxford/AstraZeneca formulation), Moderna, Pfizer/BioNTech, Janssen (Johnson & Johnson), Sinopharm



(Beijing), Sinovac CoronaVac. Guests who have been inoculated with vaccines other than those listed below will not be permitted ashore.

### **FACE MASK REQUIREMENTS**

In order to provide the highest level of health and safety during your voyage, as of December 18<sup>th</sup>, 2021 all Oceania Cruises vessels have implemented a mandatory masking policy for all guests onboard with the following exceptions:

- While indoors unless actively eating/drinking or seated at a table in a dining setting.
- While outdoors in crowded settings when physical distancing cannot be achieved.

### **VOYAGE ENTRY REQUIREMENTS BY DESTINATION - LOS ANGELES, USA THROUGH BORA BORA, FRENCH POLYNESIA**

The entry requirements by destination listed in the following pages covers the destinations of Hawaii and French Polynesia through February 2<sup>nd</sup>. You will receive additional updates for destinations as they are received.

#### **HAWAII**

**Testing Required:** All travelers entering the islands of Hawaii must be in possession of a negative covid-19 test result that is not more than one day (1 day) old at the time of arrival. Required testing will be provided to all guests by the Insignia's medical team and there will be no charge for the testing.

Entry testing will be considered valid for the entirety of our stay in the islands of Hawaii.

**Entry Restrictions:** All guests must upload and validate their vaccination records with the State of Hawaii's online "Safe Travels" portal. We strongly suggest that you register with Hawaii's "Safe Travels" portal prior to departure.

**NOTE:** All guests will be treated as "domestic travelers" upon arrival as we will have arrived in Hawaii via Los Angeles.

#### **FRENCH POLYNESIA**

**Testing Required:** All travelers must be in possession of a negative covid-19 antigen test result that is not more than 48 hours old upon arrival. Required testing will be provided to all guests by the Insignia's medical team and there will be no charge for the testing.

**Entry Restrictions:** All travelers must register on the French Polynesian Electronic Travel Information System not more than 30 days but not less than six (6) days prior to arrival: <https://www.etis.pf/>

### **MEXICO**

**Testing Required:** No

### **GUATEMALA**

**Entry Restrictions:** All guests must wear faces masks when ashore.

### **HONDURAS**

**Testing Required:** No

**Entry Restrictions:** None

### **COSTA RICA**

**Testing Required:** No

**Entry Restrictions:** All guests must wear faces masks when ashore.

Vaccination Note: Guests must have completed a vaccination schedule against COVID-19 with the last dose administered 14 days before the cruise's departure. Approved vaccines for entry are: Moderna, Pfizer-BioNTech, AstraZeneca, Johnson & Johnson, Sinopharm, Sinovac or Covaxin. Guests inoculated with vaccines others than those listed above may be denied permission to proceed ashore.

### **PANAMA**

**Testing Required:** All guests must submit a negative covid-19 PCR test not older than 72 hours upon arrival. The ship's medical team will facilitate testing at no cost.

**Entry Restrictions:** All guests must wear faces masks when ashore.
